## Report of Patient with Major Vision Limitation Minnesota State Services for the Blind

Minnesota Statutes, chapter 248.011, Section1, "Reporting of newly blinded individual" state that newly diagnosed cases of legal blindness must be handled as contained in the following:

 You must advise your patient (or the family) of the existenece and role of Minnesota State Services for the Blind (SSB),

#### and

 After obtaining your patient's consent, you must, within 30 days, advise SSB of the patient's name. After receiving the name of your patient, we are required to contact the person within 30 days and to provide them with details on the services available through SSB. Your efforts to initiate the process will be greatly appreciated.

#### To refer your patient:

- Advise patient of services provided by SSB;
- Obtain patient consent (Consent form on back);
- · Complete referral information;
- · Fold, tape (not staple), and mail.
